
Gwen Carr's Tireless Fight for Justice in the Wake of Eric Garner's Death



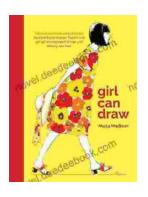
